

FEBRUARY 1, 2019 CBLAC CONFERENCE CALL

1) Sports Medicine Licensure Clarity Act of 2017 – Physicians, athletic trainers and other sports medicine professionals who travel to another state with an athletic team to provide medical care for that team will now have the benefit of being able to provide medical services for members of the team within the scope of the license in their “home” state and also have the protection of the professional liability insurance policy as if the services were provided in their “home” state. See the definition of “covered sports medicine professional” below – it could be read to include more than physicians and athletic trainers. It was part of the massive FAA Reauthorization Act of 2018 which was signed into law last month.
