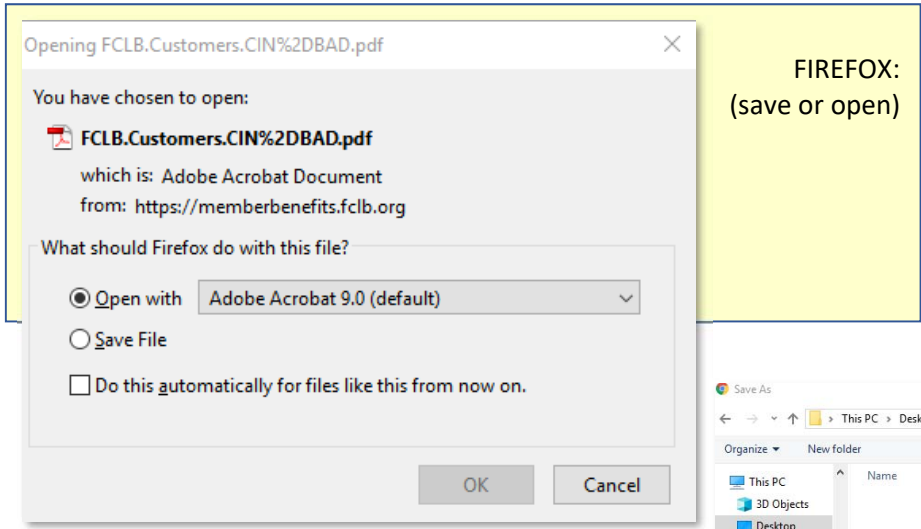

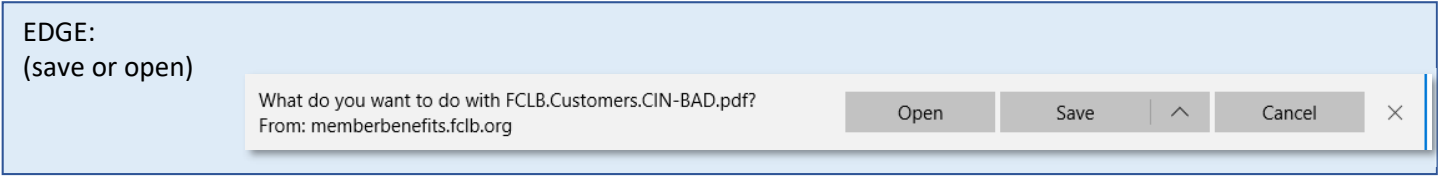
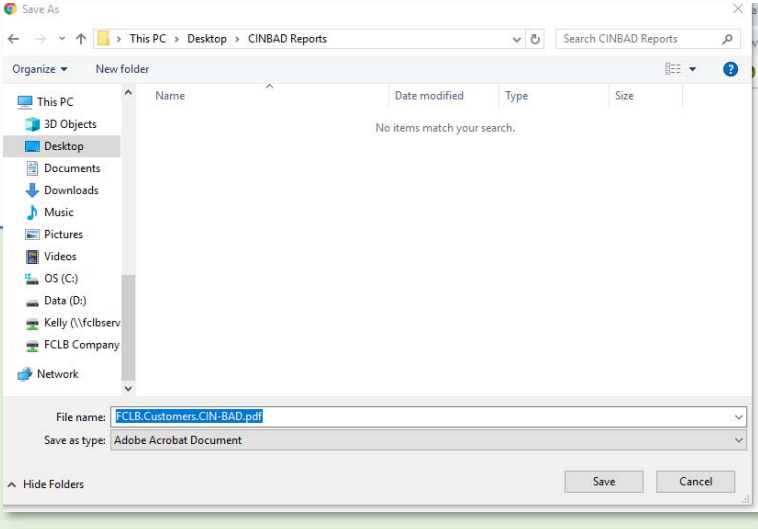

Trouble-Shooting

ZERO RESULTS

If **nothing loads**, there are no matching records. You may wish to check your spelling, or modify your search. A couple ways to help expand your search:

- **Search without a first name** - some license holders may use a derivative that does not match your search (Bob instead of Robert, for instance)
- **Remove punctuation and spaces** – names that contain non-alpha characters may have variations in the way they are entered (O'Donnell may appear as ODonnell; Van Ness may appear as VanNess)

TOO MANY RESULTS

If **too many records load**, your search may be too broad. You may do one of a couple things:

- Try your search again, but **ADD** a first name to narrow the results
- Browse the results to find your target – click the blue arrows ◀▶ to page through the results.
